OUR ACQUISITION OF CONSERVATION EASEMENTS OVER THE MAILLIARD WEST AND MIDDLE RANCHES PROTECT MORE THAN 11,000 ACRES OF REDWOOD FORESTLAND AND RIPARIAN HABITAT AND SECURE THE STABILITY OF THE REGIONAL ECOSYSTEM. THE LEAGUE ALSO EXPANDED THE GROVE OF OLD TREES PARK TO 48 ACRES BY PURCHASING A NEIGHBORING 15-ACRE PROPERTY AND DEEDING IT TO LANDPATHS, THE GROVE'S OWNER.
