

WORK CONTINUED ON OUR MILL CREEK ECOLOGICAL RESTORATION PROJECT IN A 25,000-ACRE TEMPERATE RAINFOREST NOW PART OF DEL NORTE COAST REDWOODS STATE PARK NEAR THE CALIFORNIA-OREGON BORDER. THIS FOREST IS HOME TO ANCIENT REDWOODS, HUNDREDS OF NATIVE PLANT SPECIES AND TWO CRITICAL SALMON-BEARING STREAMS. THE PROJECT IS A UNIQUE OPPORTUNITY TO RESTORE OLD-FOREST CHARACTERISTICS TO A REDWOOD FOREST THAT HAD BEEN LOGGED. MORE THAN 558 ACRES OF YOUNG FORESTS WERE THINNED TO CHANGE THE SPECIES COMPOSITION BACK TO COAST REDWOODS. THREE MILES OF LOGGING ROADS WERE REMOVED TO PREVENT SEDIMENT FROM FLOWING INTO STREAMS AND SUFFOCATING EGGS OF WILD SALMON, AN INTEGRAL PART OF THE REDWOOD ECOSYSTEM. OUR STEWARDSHIP WORK INCLUDED MONITORING AND MANAGING THE 26 CONSERVATION

OUR RESEARCH GRANTS PROGRAM CONTINUED TO EXPAND SCIENTIFIC KNOWLEDGE OF REDWOOD ECOSYSTEMS AND THE IMPACTS OF GLOBAL CLIMATE CHANGE ON REDWOOD FORESTS BY AWARDED 8 GRANTS TOTALING \$93,665 TO SCIENTISTS AT HUMBOLDT STATE UNIVERSITY, UNIVERSITY OF CALIFORNIA, BERKELEY, UNIVERSITY OF CALIFORNIA, SANTA CRUZ, UNIVERSITY OF CALIFORNIA COOPERATIVE EXTENSION OF LAKE COUNTY, SAN FRANCISCO STATE UNIVERSITY AND USDA FOREST SERVICE PACIFIC SOUTHWEST REGION. THE LEAGUE ALSO PROVIDED AN ADDITIONAL \$14,510 GRANT TO SEQUOIA PARKS FOUNDATION TO CONDUCT SYNTHESIS OF EXISTING GIANT SEQUOIA RESEARCH TO IMPROVE MANAGEMENT OF THE SPECIES. THE LEAGUE'S EDUCATION PROGRAM CONTINUED GROWING REDWOOD ENTHUSIASTS TO PROMOTE THE FUTURE PROTECTION OF THE REDWOODS. WE AWARDED 40 GRANTS IN

THE POLICIES AND PROCEDURES ALSO INCLUDE PROVISIONS FOR PREPARATION AND RETENTION OF REPORTS OF ALL MONITORING ACTIONS AND INSPECTIONS AND DOCUMENTATION OF COMMUNICATIONS WITH LANDOWNERS AND NEIGHBORING PROPERTY OWNERS, PROCEDURES RELATING TO ENFORCEMENT OF THE CONSERVATION EASEMENT TERMS AND PROCEDURES FOR THE HANDLING OF LANDOWNER INQUIRIES AND REQUESTS
