# Terms, Conditions and Official Rules

# **Rules Summary:**

- The completion of an online Entry Form is required to enter this contest. Entry Forms must be submitted by an adult age 18 or older on behalf of the child participant. The online Entry Form is available at readingtheredwoods.org.
- 2. One entry per child participant, grade Kindergarten through 5.
- 3. Contest participants will complete the following activities:

  - c) Take a selfie with your favorite tree, write a story about the redwoods, or draw a picture and post to an adult's Facebook or Instagram with #Stand4Redwoods
  - d) Find the redwood park closest to your home using ExploreRedwoods.org and read about the park's history and features.
  - e) Look into a redwood forest right now via a webcam using a link on the League's website.
- Terms, Conditions and Offical Rules

#### Sponsor

The "Reading the Redwoods contest" (the "Contest") begins March 10, 2018, at 8 a.m. U.S. Pacific Time and ends May 10, 2018, at 5 p.m. U.S. Pacific Time. By submitting an entry, each entrant agrees to the Official Rules and warrants that his or her entry complies with all requirements set out in the Official Rules. No purchase or fee is necessary, and a purchase will not increase your chances of winning.

All participants who have submitted the online Finished Form will automatically be entered to win the Grand Prize. Prize winners will be selected through a random number generator. The Contest is open only to legal residents of the United States of America currently enrolled in school in grades Kindergarten through 5. ### **Rules & Details**

The Contest is for children in grades K-5 in the United States. An adult (parent, guardian, family member, or other) will complete an online Entry Form in order to enter the contest. The Entry Form and details about the Contest are available at readingtheredwoods.org. Entry Forms must be submitted by an adult age 18 or older on behalf of the child participant. One entry per child participant. Once the Entry Form has been completed and submitted online, Contest participants will complete the following activities:

- Read two books about redwoods, forests, trees, and nature. Links to book lists will be provided along with encouragement to visit public libraries and local bookstores.
- b) Listen to one audio book about redwoods, forests, trees, and nature. Links to audio book sites and forest/tree/ nature books will be provided.
- c) Take a selfie with your favorite tree, write a story about the redwoods, or draw a picture and post to an adult's Facebook or Instagram with #Stand4Redwoods

All participants who have completed the Entry Form will automatically be entered to win the weekly prize packages. Prize winners will be selected through a random number generator. The winners will be notified by email.

The Grand Prize will be awarded to one participant after the completion of the contest on May 10, 2018. All participants who have submitted the online Finished Form will automatically be entered to win the Grand Prize. Prize winners will be selected through a random number generator. The winner will be notified by email.

Each winner is asked to submit a photo of themselves and information for a "Meet the Winners" feature on SaveTheRedwoods.org (first name, city where they live, and why they love the redwoods). First names and photos of winners will be used for announcement and promotional purposes only, with parent's/guardian's permission.

### Releases

The electronic signature of a parent or legal guardian is required for all submissions by entrants under 18 years of age.
